TERMS & CONDITIONS

PLEASE NOTE: SOME PARTICIPATING SHOP FRONTS MAY HAVE LIMITED SPACE. (Under 1 meter square). CONDITIONS SELECTED WORKS WILL BE MATCHED IN SHOP FRONTS THAT BEST SUIT THE ENTRY.

- The total prize pool value of the competition is over \$1,000 to be made up
 of cash and goods (which may include gift vouchers). Greater Blue
 Mountains Creative Arts Network (GBMCAN) is the co-ordinator presenting
 the 2023 ArtStreet Competition.
- Entries must be submitted by 6pm Friday 2 June 2023 via the 2023 online
 ArtStreet Entry Form. The image file/s (bmp, jpg, gif) size should not exceed
 5mb each and should be cleared labelled with ARTIST NAME_TITLE OF
 WORK.
- 3. The file name/s should correspond with the title of the work/s on the entry form.
- The WINTER MAGIC ARTSTREET PRIZE is open to any resident of the Blue Mountains, Sydney Australia (as defined by the relevant Local Environmental Plan (LEP). Finalists may need to provide identification if requested.
- 5. Submitted Artworks are to best represent the **WINTER MAGIC ARTSTREET PRIZE theme (LOVE).**
- 6. Submitted Artworks must be the original work of the entrant and not breach any copyrights.
- 7. As there may be limited space in some participating shop front windows, competing Artists should take into consideration the final installation or framed works size. (Suggested maximum size ratio is 1 x 1 meter square)
- 8. The Artist MUST ensure they make themselves and their artwork available to be hung/installed between the **5th-11th of June 2023**. Final date and time of bumping works in will be as per prior arrangement with the shop owner/manager. Works NOT installed/hung by the 11th of June may be deemed withdrawn from the competition.



- 9. It is the artist's responsibility to hang and curate the works in the appointed shop front.
- 10. A non-refundable entry fee shall be paid for the work/s (maximum of two) entered and must accompany a completed online entry form.
- 11. Payment is to be made using the online ArtStreet entry form portal, on the GBMCAN website via credit/debit card or an electronic bank transfer.
- 12. Entry will be considered accepted upon clearing of funds in the GBMCAN bank account. A limit of two works per artist may be submitted.
- 13. Each entry will be subject to the entry fee. Entry fee/s is/are non-refundable and contributes to administration, handling and prizes.
- 14. For painting, drawing or photographic entries polyptych submissions with works that clearly span multiple canvasses or frames shall be treated as a single submission.
- 15. ARTWORKS must be CLEARLY MARKED on the reverse or appropriate area with the artist's name, address, contact details, the title of the work, medium, size and the current retail price (incl. GST).
- 16. The **Winter Magic Artstreet Art Prize** and its agents and participating Shop Owners/Managers and their staff will exercise all due care with the works submitted but will not be responsible for any loss or damage suffered whatsoever to any work while in transit or under its control.
- 17. Each entrant shall indemnify the Winter Magic Festival, GBMCAN, ArtStreet Art Prize and its agents against loss or damage suffered to his/her work.
- 18. Each artist is responsible for his/her own insurance cover/s. GBMCAN members who participate in ArtStreet event are covered for Public and Products Liability insurance of \$20 million.
- 19. All artists selected authorise **Winter Magic Festival**, **GBMCAN** and **Artstreet Art Prize**, formally and irrevocably, to publish their works free of copyright, totally or partly, in all publications (catalogues, folders, posters, slide shows, brochures etc) related to this art prize, as well as on the official website and social media pages.
- 20. Any participating artist whether individual or part of a school project, who are under the age of 18 will require the following:
 - a. Consent for the republishing of their works free of copyright, totally or partly, in all publications (catalogues, folders, posters, slide shows, brochures etc) related to this art prize, as well as on the official website and social media pages.
 - b. Permission from a parent, or legal guardian to enter the ArtStreet Youth Prize competition via the online entry form available on the GBMCAN website.
 - i. In the case of participating School groups. They will require the teacher to enter on behalf of the group. The



- Teacher/School will be responsible for seeking permission from parents, or legal guardians as and if required.
- **c.** Supervision during the installation their artwork from/by their parent, legal guardian or authorised person such as a School Teacher or Relative.
- 21. **Winter Magic Festival, GBMCANand Artstreet Art Prize r**eserves the right to exhibit the SELECTED WORK/S ONLY for the exhibition period.
- 22. All exhibited works sold or not sold during this period **MUST BE COLLECTED** no later than **Monday 17th July 2023**, unless other prior arrangements have been made. Works not collected will be removed and disposed of.
- 23. The judges' decision is final on all aspects of awarding the Prizes, and no correspondence or appeal will be entered into or considered.
- 24. A decision by a majority of the judges on any issue shall be deemed to be a valid and binding decision of the judges as a whole.
- 25. **SELECTED APPLICANTS ONLY** will be notified no later than the **4th JUNE** via email or phone.
- 26. Freight costs and all other charges relating to delivery and collection of artworks entered into **Winter Magic Festival**, **GBMCAN** and **Artstreet Art Prize** are the sole responsibility of the artist. Artworks will not be accepted unless delivered and returned free of all freight and other charges.
- 27. ArtSt**reet** reserves the right to reject any submission without explanation.
- 28. Terms and conditions are subject to change and entrants will be notified and updated in writing via email.
