TERMS & CONDITIONS

NOTE: SOME PARTICIPATING SHOP FRONTS MAY HAVE LIMITED SPACE.

CONDITIONS

SELECTED WORKS WILL BE MATCHED IN SHOP FRONTS THAT BEST SUIT THE ENTRY.

The total prize pool value of the competition is over \$1,000 to be made up of cash and goods (which may include gift vouchers). **Great Blue Mountains Creative Arts Network (GBMCAN)** is the co-ordinator presenting the **2023 ArtStreet Competition**.

Entries must be submitted by **6pm Friday 26th May 2023** via the 2023 online ArtStreet Entry Form. The image file/s (bmp, jpg, gif) size should not exceed 5mb each and should be cleared labelled with **ARTIST NAME_ TITLE OF WORK**.

The file name/s should correspond with the title of the work/s on the entry form. If this is not possible, please contact **ArtStreet (via phone)** to discuss other viewing arrangements.

The **WINTER MAGIC ARTSTREET PRIZE** is open to any resident of the **Blue Mountains**, Sydney Australia (as defined by the relevant **Local Environmental Plan (LEP)**). Finalists may need to provide identification if requested.

Submitted Artworks are to best represent the **WINTER MAGIC ARTSTREET PRIZE theme (LOVE)**.

Submitted Artworks must be the original work of the entrant and not breach any copyrights. As there may be limited space in some participating shop front windows, competing Artists should take into consideration the final installation or framed works size.



The Artist MUST ensure they make themselves and their artwork available to be hung/installed between the 2nd of June **and** the 10th of June 2023. Final date and time of bumping works in will be as per prior arrangement with the shop owner/manager. Works NOT installed/hung by the 10th of June may be deemed withdrawn from the competition. It is the artist's responsibility to hang and curate the works in the appointed shop front.

A non-refundable entry fee shall be paid for the work/s (maximum of two) entered and must accompany a completed online entry form. Payment can be made by direct deposit made payable via electronic banking transfer or online payment link per the online **ArtStreet** entry form.

Entry will be considered accepted upon clearing of funds in the **GBMCAN account**. A limit of two works per artist may be submitted. Each entry will be subject to the entry fee. Entry fee/s is/are non-refundable and contributes to administration, handling **and prizes**.

For painting, drawing or photographic entries – polyptych submissions with works that clearly span multiple canvasses or frames shall be treated as a single submission.

ARTWORKS must be **CLEARLY MARKED** on the reverse or appropriate area with the **artist's name, address, contact details, the title of the work, medium, size and the current retail price (incl. GST)**.

The **Winter Magic ArtStreet Art Prize** and its agents and participating Shop Owners/Managers and their staff will exercise all due care with the works submitted but will not be responsible for any loss or damage suffered whatsoever to any work while in transit or under its control. Each entrant shall indemnify **the Winter Magic Festival, GBMCAN and ArtStreet Art Prize** and its agents against loss or damage suffered to his/her work. Each artist is responsible for his/her own insurance cover/s. GBMCAN members who participate in ArtStreet event are covered for Public and Products Liability insurance of \$20 million.

All artists selected authorise **Winter Magic Festival, GBMCAN and Artstreet Art Prize**, formally and irrevocably, to publish their works free of copyright, totally or partly, in all publications (catalogues, folders, posters, slide shows, brochures etc) related to this art prize, as well as on the official website.

Winter Magic Festival and Artstreet Art Prize reserves the right to exhibit the **SELECTED WORK ONLY** for the exhibition period.



All exhibited works not sold during this period **MUST BE COLLECTED** no later than **Monday 17th July 2023**, unless other prior arrangements have been made. Works not collected will be removed and disposed of. The judges' decision is final on all aspects of awarding the Prizes, and no correspondence or appeal will be entered into or considered.

A decision by most of the judges on any issue shall be deemed to be a valid and binding decision of the judges as a whole.

SELECTED APPLICANTS ONLY will be notified no later than the **2nd of JUNE** via email. Freight costs and all other charges relating to delivery and collection of artworks entered into **Winter Magic Festival, GBMCAN and ArtStreet Art Prize** are the sole responsibility of the artist. Artworks will not be accepted unless delivered and returned free of all freight and other charges.

ArtStreet reserves the right to reject any submission without explanation. Terms and conditions are subject to change and entrants will be notified and updated via email.
